CSR in Himcahal Pradesh tehsil invigorates 300 schools

Industrial houses at a Tehsil in Himcahal Pradesh has set an example over corporate social responsibility to be emulated for the rest of India by

aiding over 300 government schools in the town. The tehsil of Nalagarh, which is the industrial hub of the state, has 350 government schools, of which more than 300 have been aided in some way or other by various corporate companies running in the area. Cadbury, Johnson and Johnson, Ambuja, Cipla and Torrent are some of the names which have been helping the rural schools. The involvement of the corporate in the mentoring of the government schools, which are usually devoid of resources, is a direct result of combined efforts of local administration and local body representatives. The companies chip in with desks, chairs and tables for the teachers and also help in the maintenance of schools, besides many schools have been adopted for annual maintenance and other needs.

RIL, ONGC on top-100 global list for education CSR spending

Only two Indian companies Reliance Industries and ONGC have managed to made to a list of the world's top-100 companies in terms of CSR spending on education, a new study said still, the Indian companies fare better than their counterparts in China and Japan in terms of the average CSR spending on education. On the top-100 list, Reliance Industries is also ranked very low at 80th position, while ONGC is further down at 91st, according to the world's first comprehensive study into global corporate education CSR spend, published today by the Varkey

Foundation in partnership with UNESCO. "The promotion of education and employment-enhancing vocational skills were two key focus areas for Indian companies, especially at primary and secondary levels," the report said.



Modi Asks PSU Banks To Work On A Single CSR Project

Prime Minister Narendra Modi has asked to the chiefs of state-run banks to carry out a single project under the corporate social responsibility (CSR) scheme. At present, every bank supports different CSR projects. Modi said this while speaking to the bankers at Gyan Sangam - a two-day workshop held in Pune recently. As per the revised Companies Act, corporate houses have to spend at least 2% of their net profit for social welfare schemes under CSR. Banks, which come under the Banking Regulations Act, are exempted from the Companies Act. However, as per a directive by the Reserve Bank of India (RBI), "they can spend up to 1% of their previous year's net profit to support social causes." During the gathering, the PM pointed out that pooling of resources of all PSU banks for a single project would result in a more meaningful deployment of funds as it would result in economies of scale. He suggested that each year, banks can take up different projects."





Private companies to build toilets in New Delhi through CSR

NEW DELHI: Far-flung and less-developed areas in New Delhi Parliamentary constituency could soon have public toilet facilities built by private companies as part of their Corporate Social

Responsibility (CSR) activities. The initiative taken by New Delhi MP Meenakshi Lekhi in her constituency under the Swachh Bharat Abhiyan seeks to bring in public-private-partnership for building toilets in public places. Besides urban areas, it will benefit residents of rural and slum areas, JJ colonies and undeveloped bastis, among others.

Karnataka HC asks state govt to make better use of CSR funds

BENGALURU : The Karnataka high court has asked the state government to make out all efforts to bring back before the commencement of next academic year the remaining 17,000 odd children who are still out of school . A division bench headed by Chief Justice D H Waghela also asked the state government to have special focus on those taluks/districts in the backward region of the state where the number of such children varies from 700 to 1000 plus.



The bench also gave an example of Chitapur in Kalaburugi district which had still an estimated 1225 children remaining outside the school, as per government's own records. "You have to take action as these areas are covered under Article 371-J of the constitution" the bench said.

While noting that the last stretch in the constitutional mandate of ensuring all children in schools a difficult task, the bench asked the authorities to take the help of nongovernmental organizations as well as nonprofit organizations in the said exercise. The bench also asked the state to explore the possibility of utilizing the corporate social responsibility (CSR) funds for upgrading the facilities at the schools like providing sports kits to children etc.

Companies can collaborate with each other for CSR

In a move that could benefit the corporate sector at large, the government has allowed companies to enter into collaboration with each other to engage in corporate social responsibility (CSR). The Companies Act had earlier prescribed companies can do CSR work only on their own or through a holding, subsidiary or associate company.

The ministry of corporate affairs has issued a notification to amend the CSR provision in the new Companies Act, allowing two companies to collaborate with each other on their own, or through their holding, subsidiary or associate companies. These two companies can form a trust, society or another third company for CSR work. "Companies would now be able to undertake CSR activities together with other entities, whether forming part of the same group or otherwise, through a separate legal entity," said Sai Venkateshwaran, partner and head of accounting advisory services, KPMG in India. Companies above a threshold of their earnings have to spend a portion for CSR or explain the reasons for not doing so to the shareholders. The rules have permitted collaborative CSR efforts between unrelated entities, and this amendment would help operationalise that using a separate legal entity structure, he added. - **Compiled by CS B Kiran Kumar Gupta, Company Secretary, Hyderabad**

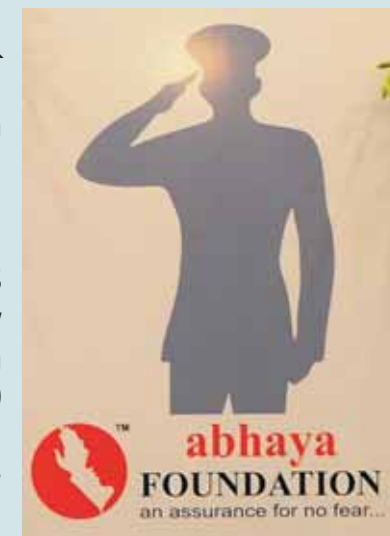

I think we must adopt some practices for these homeless.

1. we must immediately put a small paper ad on the day of admission itself -- please see if in some newspaper we can get some volunteer to give us concession rates
2. we must print about 20 copies of this notice and stick around area where this person is picked up from, keep one in Abhaya notice board, and keep one in Ibrahimpatnam police station.
3. We must cover ourselves from all legal / medical problems that come across. Let us consult a lawyer and a senior police official in this matter for advise. The issue will come up if someone develops serious condition or dies or gets crippled or if some rouge relatives come up with fancy claims.
4. Legally we must appoint someone as a coordinator at Abhyaya(NOT Kusuma), so that they can be reached in case someone comes forward. - **Srikanth Natarajan, Volunteer, Hyderabad**

Hope you remember this boy who was a lead role in abhaya short film... Ramesh whose family is supported by abhaya since last 3 years. His both brothers are studying at Vivekananda Hostel, LB Nagar, Hyderabad. Ramesh is suffering from pain in the stomach last month and on emergency he was admitted at Gandhi Hospital. Doctors diagnosed a hole in his large intestine and performed a surgery. There were no hopes but he was saved almost from the deathbed. He is recovering now and abhayans Vinod, Satya Prasad and Siva Krishna went to him. Though the treatment is free, they struggled for transportation and food expenses. Abhaya provided Rs.5000/- for their family, as there are no one to take care of them. He had a surgery. Also told him to move to abhaya Home with his ailing mother in the soonest possible opportunity. Doctors expressed concern over his health conditions. 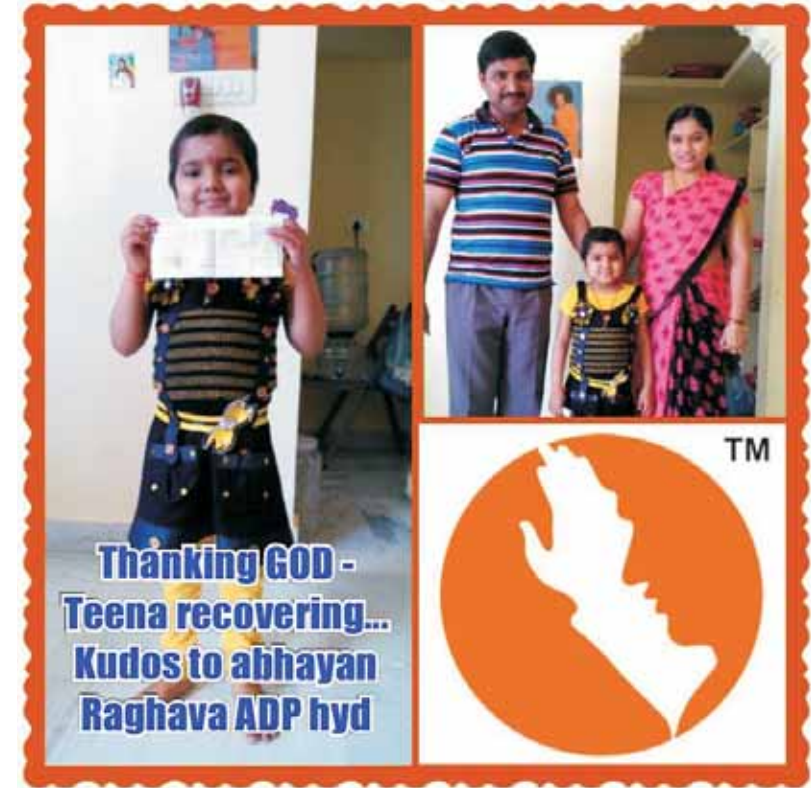
Mission Umacchandar
